Once all required information is submitted, the user is presented with the "Instructions". The most important rule to realize is that an assessment cannot be saved and restarted. Once started, it must be completed. If an assessment is stopped for any reason, users will be required to start a new assessment.

After reading the instructions, users will be presented with a new window within PayPal. Users will be given the option to pay the \$100 fee with either a PayPal account or a credit/debit card.

Once payment has been received, users will be returned to the assessment (ClassMarker) and begin reviewing the material.

The assessment is made up of two types of questions. There are multiple choice and True/False. Users only need to select the appropriate answer and click next to move onto the next question.

Each screen containing a question will present the user with the following information:

- The number of the question they are currently viewing

- The question
- The choice of answers
